ORDER: CANCELLATION OF  
ELECTION AND RE-RUN  
ELECTION

April 11, 2022

This determination addresses certain election irregularities that require the cancellation of the current election among Mechanics and Related Employees at Sun Country, Inc. The Board also orders a re-run of the election.

PROCEDURAL BACKGROUND

On March 2, 2022, the Aircraft Mechanics Fraternal Association (AMFA) filed an application alleging a representation dispute among Mechanics and Related Employees of Sun Country, Inc. (Carrier). This matter was assigned National Mediation Board (NMB or Board) Case No. R-7578 and Josie G. M. Bautista was assigned to investigate. These employees are currently unrepresented.

The Board found a dispute to exist and authorized a mail ballot election on March 22, 2022. Ballots were mailed on April 6, 2022. On April 9, 2022, the Board received reports that some employees received ballots at their addresses with mailing labels bearing the names of other employees in the craft or class. The Board also received reports that the ballots mailed to the employees contained a printing error and were missing the boxes necessary for the employees to vote.

ORDER

In view of the printing errors with the mailing labels and the ballots, the Board hereby cancels the ongoing election in this case and orders a re-run.

Pursuant to Manual Section 12.1 of the NMB's Representation Manual (Manual), the Carrier is hereby required to furnish, within five calendar days, alphabetized peel-off labels bearing the names and current addresses of those employees on the list of eligible voters. The list of eligible voters will include those employees eligible in the first election with the exception of those employees who have left the craft or class. The Carrier will post the attached Notice to Employees. The Carrier will also be provided with copies of the Notice and Rules of Election for the Re-Run Election. Both of these documents must be posted by the Carrier where notices to employees are customarily posted at appropriate stations.
